# GLEN OSBORNE BOROUGH MINUTES APRIL 18, 2023 COUNCIL MEETING

## **APPROVAL OF MARCH 21, 2023 COUNCIL MINUTES**

A motion was made by John Orndorff, seconded by Bill Monski, to approve the Council Meeting Minutes. Council voted 6-0, to approve the Minutes.

## **APPROVAL OF APRIL 4, 2023 COMMITTEE MINUTES**

## **MAYOR'S REPORT**

Mayor Carrier reviewed the March Police Report. Mayor Carrier described a two-car accident on Ohio River Boulevard that involved a vehicle with drugs hidden inside one of the cars. Mayor Carrier was pleased to report that the owner of 531 Sycamore Road complied with requests from Police Officer Marty Zimmer and Code Enforcement Officer Clint Reilly and removed the bags of garbage and debris scattered along Sycamore Road.

### **SECRETARY'S REPORT**

The Borough received \$12,160 real estate transfer tax from the sale of 604 Davis Lane, 701 Tega Cay and 206 Osborne Lane.

A payment of \$99 was received from Magistrate Ford's District Court for the month of March.

A payment of \$29 was received from Allegheny County's Court of Common Pleas for a DUI vehicle code violation involving a controlled substance.

A note of appreciation was received from John and Peggy Wick for the Borough's expression of sympathy in the passing of John's mother.

The Borough received a report from the PA Department of Environmental Protection (DEP) stating that during the first quarter of 2023, none of Glen Osborne's residents used Waste Management's Household Hazardous Waste Door-to-Door program.

Advance notification was received from Verizon advising that the cable television franchise agreement granted by the Borough of Glen Osborne and held by Verizon expires on November 16, 2025. Verizon provided notice that it seeks renewal of its television franchise and requested that the Borough commence with renewal proceedings pursuant to section 626 of the Communications Act.

## **SOLICITOR'S REPORT**

Solicitor Stone reported that he is in the process of preparing a steep slope ordinance for submission to the Planning Commission and the County, pursuant to the Steering Committee's progress updating the Borough's Zoning and Subdivision and Land Development Ordinance (SALDO). Solicitor Stone's associate Anna Hosack will assist and handle the requirements for advertising.

Salt Storage arrangements with Sewickley need to be finalized before Solicitor Stone can notify Sewickley Heights regarding our Salt Storage agreement.

## **PUBLIC SAFETY**

Tom Huddleston reported that PennDOT is going to install special equipment for the audible push buttons at the intersection of SR 65 and Beaver Road/River Road/Red Gate that will create a TOD (Time of Day) volume adjustment. There will be an automatic "Day" and a lower "Night" volume setting.

### **EMERGENCY MANAGER'S REPORT**

Bill Monski reported that he and John Wick, Jim Cohen and Jeremy tested the emergency generator for the traffic signals.

Bill Monski is registered to attend a special FEMA Evacuation Planning Course on April 26<sup>th</sup>, in Somerset, Pennsylvania.

### **PUBLIC SERVICES**

Mary Scalercio reported that signs have been posted regarding our military banner program. Orders can be submitted to Bill Monski through April 30<sup>th</sup>.

## **PUBLIC WORKS**

John Orndorff reported that he has a meeting scheduled on April 21<sup>st</sup> with Sewickley Borough Manager Donna Kaib to discuss Sewickley's Revised Act 537 Plan and explore the possible opportunity of storing salt at Sewickley Borough's facility.

## **FINANCE**

Holly Merriman reported that she and Diane Vierling took advantage of PLGIT's investment rates as of March 23, 2023, and purchased a 120-Day \$200,000 CD at 5.41% with a maturity date of July 26, 2023. We also have accounts with PGLIT: 90-Day Term funds at 4.93%, PGLIT Reserve funds at 4.76% and PGLIT Class funds at 4.64%. President Huddleston thanked Holly Merriman and Diane Vierling for carefully monitoring the Borough's accounts and utilizing PLGIT's current rates.

On April 27, 2023, Laura Ludwig (HRG, Inc.) will meet with the Steering Committee to continue updating the Borough's Zoning and Subdivision and Land Development Ordinance (SALDO) including topics such as steep slope, lot size and setbacks.

At the request of Tom Huddleston, at 8:22 p.m. Council recessed into Executive Session to seek legal advice on matters affecting the Borough. Council reconvened at 8:35 p.m.

There being no further business, on motion of Bill Monski, seconded by Mary Scalercio, Council voted unanimously to adjourn at 8:36 p.m.
