GLEN OSBORNE BOROUGH MINUTES OF JANUARY 16, 2018 COUNCIL MEETING

CALL TO ORDER

The regular meeting of Glen Osborne Borough Council was held in Osborne Elementary School, on Tuesday, January 16, 2018. President Thomas Huddleston called the meeting to order at 7:30 p.m.

MAYOR'S REPORT

Earlier today the Mayor and Jim Cohen met with Chief Manko. Jim will review their discussion in his Safety Committee report. Mayor Carrier reported that although Haysville and Glenfield Boroughs do not contract the service of the Sewickley Police, the December police report included incidents when Sewickley police officers responded to calls in Haysville and Glenfield.

SECRETARY'S REPORT

Waste Management has not yet provided the 2018 schedule. As soon as it is available, the Borough Secretary will make copies of the schedule and mail them to the residents.

A letter was received from Carolyn Toth thanking the Mayor and Council for the \$1,000 donation to the Sewickley Public Library.

The Borough received nearly \$6,900 Real Estate Transfer Tax from Allegheny County for the month of December for the sale of the following properties: 513 Osborne Lane, 1440 Beaver Road, and a lot on McKown Lane.

Glen Osborne's <u>2018 Meeting Schedule</u> appears in Council's January packet. The schedule was also published in the Pittsburgh Post-Gazette, along with the public notice advertising Council's intent to adopt Ordinance No. 415 amending the Street Opening Ordinance.

A packet of information was received from Columbia Gas regarding their

Jordan Tax Service has been deputized as the Borough's Tax Collector for 2018.

SOLICITOR'S REPORT

On motion of Thomas Huddleston, seconded by Bill Monski, Council was polled and all voted yes to adopt Ordinance No. 415 amending Ordinance No. 387 and providing minimum standards to safeguard persons, to protect property, and to ensure prompt and proper excavation and repair of street openings in the Borough streets and rights of way, and to control the opening or excavation of Borough streets and rights of way.

Due to the snow storm and dangerous road conditions, Solicitor Stone had an early dismissal.

PUBLIC SAFEY

Jim Cohen reviewed the discussion he and Mayor Carrier had with Chief Manko. Speed patrols in the school zone and McKown and Davis Lane are planned in the spring. Council has provided for "Special Police Detail" in the 2018 Budget. Tickets will be issued and enforced. Numerous drivers continue to exceed the speed limit, especially in the school zone.

Chief Manko highly recommended that the Borough consider purchasing special traffic cameras for the Haysville intersection. Chief Manko will schedule a meeting with a representative from Allegheny County's District Attorney's office to discuss the cost and and possible funding for the cameras.
